## Introduction

LSS believes in indigenous knowledge of traditional communities and their representatives through which they sustain their livelihood, cure diseases, conserve Natural resources. It is whole new and innovative world of the people, which has to be recognized and given due respect. LSS streamlines the people's power into development action, addressing local issues and fusing a change process.

LSS is working in 2 districts i.e Raigarh and Jaspur of Chhattisgarh including 350 villages of 209 panchayats.

LSS is working on the current and several issues of community to avail them a dignified life through their empowerment and leadership development. The works of the organization range from community organization to local self-governance and human welfare. This document represents the activities completed from April 2016 to March 2017, which emphasized on livelihood, MGNREGA, CFT, QUICK WIN, CHILDLINE 1098, TB Control, and SHG Formation.

## Childline 1098

CHILDLIne active 24 hour and in between 60 minutes of phone call the CHILDLIne team reaches the place and immediately gives service to the children. CHILDLIne Raigarh (LSS) works both for Urban and Rural children but prioritizes the need of the child. The child line team accesses the problems of children through Open-house and outreach process. To sensitize the families and relatives sensitization and information dissemination programs were done.

CHILDLInE (1098) is a project of Ministry of Women and Child development government of INDIA This is a 24 hour phone service for children who are in need of security and care along with the children who are facing the violation of child rights. The service is available for the children

### QUICK WIN - DFID PROJECT

#### **Objective of the project**

To creating awareness about Climate changes and built up Climate resilient infrastructure and durable assets through MGNREGA in village. Ensure community participation in planning process.

#### **Process**

To implement the project in target area several steps were taken. Those are:

- Social mobilization
- Interface with PRIs and Line department
- Planning and estimation
- Layout and execution
- Ensuring timely wage payment
- 



#### **Outcomes**

- 6 Individual form pond size 20x20X3mtr and 2 community Pond sanctioned and constructed in project villages
- Oil seed cultivation in Around 4.5 Acer
- In 5 villages 10 JSC formed including 214 member
- Fruit plan (Niboo,Sitafal,Kathal,Karonda) distributed in 210 HH through Horticulture dept
- 1 Hact. Sagon plantation through forest dept.
- 36 members of 3 SHGs doing fishery

## Mega watershed

Lok Shakti Samiti Raigarh is implementing the project **High Impact Mega Watershed Project, Chhattisgarh** from October 2018 in Raigarh District's of 02 block including Gharghoda block as intensive and Kharsia block as Non intensive. Total 16 staff has been appointed for project implementation. Duration of project is 04 yrs. from October 2018 to September 2022.

Activities under the project

### 1. Capacity building -

- Total 16 personal has been appointed and a two days training was imparted to them on watershed concept and DPR..
- One day training of Panchayat representatives (PRIs) has been organized in which 81 women and 109 male representatives were participated and the training was imparted on preparation of DPR and providing information about the principals and purpose of watershed. The training was done in 6 times.
- One day training of SHG/VOs has been organized in which 235 women and 37 male representatives were participated and they were prepared for DPR making and providing information about the principals and purpose of watershed.
- DPR 05 GPs has been completed namely- 1.Gharghodi, 2.Nawagarh, 3.Baronakunda, 4.Bahirkela, 5.Chotegumda

- Planning process begin through meeting villagers, SHGs, VO, PRIs, Vulnerable community. The discussions on the principle of water intake with the community were discussed in the meetings, and the activities of watershed, IGA were communicated to the people. Baseline survey was conducted as provided by the State- which includes every household detail, job card, livestock holding, present water harvesting structures etc.



Transect walk was done with the land owners, elderly people of the village, panchayat representatives, SHGs, LSS staffs, CRP. During transect walk, present use, problem in the land and expected or visualized land use was discussed. Accordingly, the intervention was proposed. Activities and structures were finalized according to the interest of the farmers. After the field visit and transect walk of all the patches, people again gathered to share the plan and make the activity map of the work taken for four years of watershed project and deliberated on the priority of the work. The landless, single women were also taken into consideration and plan for livestock rearing has been taken. Action plan was approved in the Gram Sabha of the month of January 2019.

- Mapping of Forest land of project area
- Land Levelling - 196, Farm Bunding-74, Farm Pond-77, Community Pond-7, Pond Deeping-22, Earthen Dam-9, Dug Well-171, Plantation-5, Bolder Check -61, Stop Dam-18, Cannel repairing-1, Contour trench-55, Gully Plug-48,
- The community is demanding for employments, which are being sent to MGNREGA cell.
- The PRIs and SHGs has supported to each steps from beginning of the DPR preparation till finalization and approval. They are mobilizing the job card holders to work under the MGNREGA.



## **Community Action for Climate Resilience for Sustainable Livelihood**

The project was implemented by the support of Bharat Livelihood Foundation and the under the alliance of Chhattisgarh development alliance. Project implemented through 4 partners including LSS as lead partner with BSM, Bastar, SGVS Wardrofnagar, and PARAS, Raigarh.

In order to aware the people about their rights and entitlement, the community meetings were organized and inform them about the different flagship programme of the Government of India. They were advised to participate in Gram Sabha and claim their entitlements. As result the people’s participation in Gram Sabha were increased. The PRI members of the 61 villages were imparted training for better decision making, effective

implementation and delivery of the flagship programs to people. There were 174 PRI members participated in the training and became aware about BRLF project objectives and activities. Village /GP level plans were done and submitted to GP for approval. As it was monsoon season, so MGNREGA work did not implement as per our plan. The concerned authority did not approve the plan till date. However, in spite of bottleneck 12 People were mobilised to work under MGNREGA for 135 days. They received Rs.23490 as wage.

### **Major Interventions**

- Capacitating CBOs & local Institutions to make ensure their activeness towards their rights and entitlements.
- Establishing Agri and Agri-allied based (on farm and non- farm) livelihood opportunities to ensure the food security and dignified income,
- Enhancing the crop productivity through participatory ground water management.
- PGWM in 7GPs, NPM and restoration of traditional paddy, seeds and promotion, NTFP value addition (Mahua,tarmrind,Tendu) and marketing, value addition of mushroom and Charchol.

### **Outcomes**

- a. CBOs and PRIs became aware and active towards their rights and entitlement.
- b. Active participation in Gram Sabha is increased by 70%.
- c. All targets HH are covered under Government Social Security Schemes.
- d. Farmers group formed.
- e. Need assessment of farmers is done.
- f. Improve agriculture practices are adopted. Various livelihood opportunities related to Agri & agri-allied (On-farm & Non-farm) created.
- g. Annual income of targeted HHs increased from Rs.18000/- to Rs.35000/-
- h. Various assets are created for irrigation and land got assured irrigation. Area of irrigation is enhanced.
- i. Community of 7 GP of 13 villages Know their water problem and developed the plan for water management.
- j. 130 farmers group aware about NPM and started cultivation in 780 acre of land.
- k. Income of 300 HH increased through NTFP.
- l. SHG-FPO started marketing of Charcoal and Mushroom

## Utthan

The program focus is on schedule tribes, PVTGs and weaker sections of communities who live and dwell in proximity to the tribal communities in general. Raigarh is tribal dominated district and around 70% of its population belongs to rural area. The major tribes of the Raigarh district are the Oraon, Nagesia, Kanwar, Birhor, Baiga, PahadiKorwa. These communities face extreme backwardness, chronic poverty and malnutrition in exasperated forms which leads to stunting growth rate of children up-to 40.4% below 5 years, 30.2% women affected by low body mass, 42.2% non-pregnant and 38.8% pregnant women are anemic in the region which directly linked to food and nutrition crisis. Literacy rate is also very less among tribal community.



The main aim of the program is to support the tribal communities (ST and PVTGs) through empowered animation for participation in decision making bodies (Gram Sabha) and being sensitized to access entitlements through their active involvement. Tribal are more vulnerable and marginalized due to their poor socio-economic conditions in terms of work-participation and access to various eligible government entitlements and flagship program.

- 354 children were participated in child protection week and awareness events & program.
- 20 applications for PMAY were submitted through Gram Panchayat.
- 45 applications for old age pension, 12 application for widow pension and 02 applications for PLWD were submitted to Gram Panchayat.
- 66 PVTGs HHs undertook to approve individual and community lands.
- 48 HHs open the accounts to link up with the MGNREGA for payments of wages.

- 15 PAN Card and 12 Voter ID applications were generated by presenting to CSC through team members.
- 77 PVTGs HHs was benefited through 14<sup>th</sup> finance for water source.
- 39 farmers applied for soil health card in which 10 soil sample collected and lab testing has been done.
- 50 farmers were benefited from the Turra waterfall by delivering the water to the farm through special Gram Sabha.
- 121 farmers were linked to crop insurance scheme, through REAO of Agri. Dept.
- On the National Day, 156 children's were fed Albendazole tablets.
- 33 SHG groups were benefited to providing for financial support through C.G. Government SRLM.
- Child Profiling - 235 Girls and 260 Boys total 495 profiling has been completed. 41 malnourished children were indentified.
- 15 children were admitted in the NRC Dharmjaigarh including 04 PVTGs child.
- During the anaemia campaign 15 women and 25 adolescent girls were done HB test.
- 57 Farmers has done nutrition garden in their backyard. 13 farmers adopted SRI practice in agriculture.
- 616 people were benefited by giving pure water by adding chlorination in 7 wells.
- 38 pensioners were facilitated to get old pension of total Rs. 37110/- by CSC.
- 175 house hold were facilitated to get job Under MGNREGA, in which total wage payment of Rs. 272374/- were paid for 1642 man days. Including 14 HH belongs to PVTGs, they have provided 84 day of employment of Rs. 14616/-



- A Vaccination camp conducted in Kadamdhodi PVTGs village with support of health department, where 23 women including 6 pregnant women benefited.
- 05 HH made drinking water pots platform (Machan) influenced by Utthan awareness program
- The Anganwadi Centre started in Tedasemar Village which was stopped before 3 Yrs. by facilitation of Utthan team

## Conclusion

2018-19 was an important and successful year for LSS. In order to be ready for the next year, LSS has identified its need to focus more and more on work quality and depth of implementation, moving from being an organization that provides programs for basic activities to an organization that can deliver full support all year round to beneficiaries. In order to meet this requirement, we need to have stronger strategic models and there are many internal challenges to be met.
